

GENERAL TERMS AND CONDITIONS FOR THE PROVISION OF SPORTS SERVICES DEPENDING ON THE SUBSCRIPTION PLAN AND TYPE OF SERVICES OF NEXT LEVEL FITNESS OOD

These GENERAL TERMS AND CONDITIONS FOR THE PROVISION OF SPORTS SERVICES DEPENDING ON THE SUBSCRIPTION PLAN AND TYPE OF SERVICES OF NEXT LEVEL FITNESS OOD (hereinafter referred to as the "Company"), with its registered office and management address: 1700 Sofia city, 35 Simeonovsko Shosse Blvd., fl. 3, with UIC 204479347, entered in the Commercial Register and the Register of Non-Profit Legal Entities, contact phone number: +359 2 491 0095, email: info@nextlevelfitness.bg (hereinafter referred to as "General Terms and Conditions") shall apply to the following options for using Sports Services and types of Subscription:

- EASY Subscription;
- PRO Subscription – monthly installments;
- BASIC Subscription;
- Pro Single Club – annual subscription
- Quarterly Subscription;
- Back2School – Three-month subscription;
- Weekly Fitness Subscription;
- Weekly Subscription for Group Classes and Fitness;
- Free Pass – Free Visit;
- Next Level Body Age;
- KIDS 1 Club – a subscription for children's group activities;
- Group Class – Children's Boxing;
- Group Class - Pilates Reformer;
- Individual Session – Pilates Reformer.

„Next Level Fitness“ OOD also provides sports services that are not based on a subscription model, with the specific types of services, their content, and prices publicly announced on the Club's website and on-site in the facilities, and these General Terms and Conditions also apply to them.

For the purposes of these General Terms and Conditions:

- **"Subscription"** shall mean the use of sports services for a specific or indefinite period of time.
- **"Sports services"** shall include, but not be limited to, the use of fitness halls and fitness equipment therein, as well as special lounges and recreation areas with special equipment, conducting sports classes with qualified instructors in the form of group training and other types of in-person or online sports events.
- **"Customer"** shall mean a user (natural person) who uses and pays for the sports services provided by Next Level Fitness OOD;
- **"Contract for the Provision of Sports Services"** shall mean a contract upon conclusion of these General Terms and Conditions and an Agreement for the provision of sports services depending on the subscription plan and type of services (the "Agreement"). These General Terms and Conditions and the Agreement must be provided for signature by the Customer in order to have binding force within the meaning of Art. 147a of the Consumer Protection Act.
- **"Distance Contract"** shall mean a contract within the meaning of Art. 45 of the Consumer Protection Act and shall be used for subscriptions offered both online and for other Sports Services for which the possibility of concluding a distance contract is provided. In these cases, Next Level Fitness OOD shall provide the information under Art. 47 of the Consumer Protection Act to its Customers before concluding a distance contract.
- **"Next Level Fitness OOD Facilities"** shall be all fitness halls and fitness equipment therein, as well as special lounges and recreation areas with special equipment and areas for group training, managed by Company and operating under the "Next Level Fitness Club" trademark.
- **"Facilities of Next Level Fitness OOD in the city of Burgas"** shall mean all facilities managed and operated by the Company under the "Next Level Fitness Club" trademark, located within the territory of the city of Burgas as of the date of conclusion of the Contract. An up-to-date list of the facilities is published on the Company's website.
- **"Facilities of Next Level Fitness OOD in the city of Plovdiv"** shall mean all facilities managed and operated by the Company under the "Next Level Fitness Club" trademark, located within the territory of the city of Plovdiv as of the date of conclusion of the Contract. An up-to-date list of the facilities is published on the Company's website.

All definitions mentioned in these General Terms and Conditions shall have the meaning defined therein, as well as in the [Rules for the use of sports services and for the use of the Customer Area of Next Level Fitness OOD](#).

I. TYPES OF SUBSCRIPTIONS AND SERVICES.

Depending on their specific characteristics, some or all of the following types of Subscriptions and Sports Services are offered at each of the Next Level Fitness Facilities. Not all types of Subscriptions and Sports Services described in these Terms and Conditions are offered by Next Level Fitness on a permanent or simultaneous basis. The specific types of Subscriptions and Sports Services available for conclusion depend on the respective Facility, the relevant period and the availability of the respective service. Up-to-date information regarding the Subscriptions and Sports Services offered at any given time is available on the Next Level Fitness website, in the Next Level Fitness App and/or on-site at the respective Facility. The absence of a particular Subscription or Sports Service from those currently offered by Next Level Fitness shall not constitute an amendment to these Terms and Conditions.

1. EASY Subscription

EASY Subscription: With this type of Subscription, the Customer shall have the opportunity to conclude a **Contract for the Provision of Sports Services** for an indefinite period, which cannot be longer than 12 full calendar months and shorter than 3 full calendar months. **This subscription may be concluded by concluding a Distance Contract online at the web address: <https://www.nextlevelclub.bg/tseni/>, through the Next Level Fitness App mobile application, as well as in physical locations of Next Level Fitness OOD.**

EASY Subscription shall be structured in equal monthly installments, with the first month starting from the first day of the respective calendar month. In the event that the effective date of the Contract chosen by the Customer does not coincide with the first day of the month (e.g., 12.03.2025), a proportional part of the monthly fee is due for the remaining days until the end of the month, calculated based on the number of remaining days and the total number of calendar days in it. This partial period is not included in the minimum term of three full months.

Example: If a Customer concludes a Contract on 12.03.2025, they pay a proportional fee for the period from 12.03.2025 to 31.03.2025, and the minimum term of three full calendar months begins to run from 01.04.2025.

Upon conclusion of the Contract, the Customer shall pay a deposit equal to one monthly fee. The function of the deposit is to secure the payment of the final monthly fee upon termination of the EASY Subscription with notice in accordance with these General Terms and Conditions, or the fee for an unpaid monthly period in the event of non-payment and automatic termination of the EASY Subscription.

The monthly fee for the EASY Subscription is due by the 5th day of the month to which it relates, unless otherwise agreed in the Contract for the Provision of Sports Services/Distance Contract.

After the initial period, at the beginning of each subsequent one-month period of the subscription that has not been paid, the Customer will be granted access to the facilities of Next Level Fitness OOD within the first 5 (five) days of the respective period, and from 00:00 on the sixth day, the Customer will not have access to the Company's Facilities.

Upon payment of the due fee for a one-month period, after access has been terminated due to non-payment, access shall be restored for the remaining period until the end of the relevant month, after the payment is reflected in the systems of Next Level Fitness OOD, of which the Company shall notify the Customer by email to the specified email address. The days during which the subscription was not active due to non-payment shall not be restored or transferred to another period.

In the event that the due fee for the EASY Subscription is not paid by the end of the current unpaid monthly period (i.e. by the end of the last day of the monthly period - 0:00), the EASY Subscription will be considered automatically terminated. The unpaid amount due for the EASY Subscription will be deducted from the deposit paid by the Customer. Upon automatic termination, the Customer will need to conclude a new contract for Sports Services Subscription with Next Level Fitness OOD in order to use the Company's services.

EASY Subscription shall allow for saving a bank card and activating an automatic payment option. After saving the bank card and activating the automatic payment option, the Customer shall express their unequivocal consent that an amount equal to the respective monthly subscription will be automatically withdrawn from the saved bank card for payment of the next monthly period when it becomes due, ensuring continuity of the concluded Contract. At any time, the Customer may withdraw their consent by deactivating the automatic payment option via the website or the Next Level Fitness App mobile application.

According to the [Company's Price List](#), the Customer may choose whether the EASY Subscription shall apply only to one Facility or to all Next Level Fitness OOD Facilities.

By way of exception, where the Customer has selected an EASY Subscription option valid only for one Facility, and such Facility is located within the territory of the city of Burgas or the city of Plovdiv, the Subscription shall entitle the Customer to visits to all Facilities of Next Level Fitness OOD located within the respective city.

EXAMPLE: A Customer intends to sign up for a 6-month EASY Subscription on 1 January of the respective year. On the same day, they activate their account by following the procedure at the web address: <https://www.nextlevelclub.bg/tseni/> or through the Next Level Fitness App mobile application and pay their monthly EASY Subscription fee and deposit via bank card, as the EASY Subscription can also be concluded at the physical locations of Next Level Fitness OOD. After successful confirmation of the payment made within the same day, the Customer receives a message via the provided email that the subscription is active. From that moment on, they can visit the Company's Facilities. The first monthly period expires at 00:00 on 1 February of the respective year. After the initial monthly period has expired, the Customer has a five-calendar-day grace period to pay for the next one-month period of the desired 6-month Subscription, during which they can visit the Company's Facilities. On 6 February of the respective year at 0:00, the Customer's access is suspended due to unpaid installments. The Subscription can be reactivated by 28/29 February, upon payment, for which the Customer is automatically notified by a message to the specified email address. In the event of non-payment of the Subscription by 28/29 February of the respective year, the Subscription is considered automatically terminated, and the unpaid amount due under the EASY Subscription is deducted from the deposit.

2. PRO Subscription – monthly installments

The PRO Subscription - monthly installments provides the Customer with the opportunity to enter into a Contract for the Provision of Sports Services /Distance Contract for a fixed period of 12 (twelve) full calendar months upon payment of equal monthly installments due by the end of the period in accordance with the Company's price list. The twelve-month period always begins on the first day of the respective month. If the Customer's chosen effective date for the Contract for the Provision of Sports Services /Distance Agreement does not coincide with the first day of the calendar month (e.g., March 12, 2025), a proportional part of the monthly fee will be due for the period from that date until the first day of the next calendar month. This will be calculated based on the number of remaining days until the end of the month and the total number of calendar days in it. This partial period is not included in the twelve-month term of the PRO Subscription – Monthly Installments. The fee for each of the subsequent twelve months, starting from the beginning of the first full calendar month (i.e., from the 1st day of the month following the partial period month), is due in full.

Example: If the Customer chooses the Contract for the Provision of Sports Services /Distance Agreement to become effective on March 12, 2025, a proportional part of the monthly fee will be due for the period from March 12, 2025 to March 31, 2025. The twelve-month subscription term will begin on April 1, 2025, and will end at 00:00, on April 1, 2026, with a full monthly fee due for each of these twelve months.

The subscription entitles to an unlimited number of visits per day to all the Facilities of Next Level Fitness Ltd. and entitles to 1 /one/ visit per day to group classes.

PRO subscription - monthly installments can be concluded through a Distance Contract online at: <https://www.nextlevelclub.bg/tseni/>, through the mobile application "Next Level Fitness App", as well as in physical locations of Next Level Fitness Ltd.

The Monthly Subscription Fee is due by the 5th day of the month to which it relates, unless otherwise agreed in the Contract for the Provision of Sports Services /Distance Contract.

PRO subscription - monthly installments allows you to save a bank card and activate an automatic payment option. By memorizing the bank card and activating the automatic payment option, the Customer expresses his/her unequivocal consent that an amount equal to the respective monthly subscription will be automatically withdrawn from the memorized bank card to pay the next monthly fee when the same becomes due, guaranteeing the continuity of the concluded Contract. At any time, the Customer may withdraw his/her consent by deactivating the automatic payment option via the website or the Next Level Fitness App. Upon deactivation of the automatic payment option, the Customer shall independently make the monthly payments within the terms set out in these Terms and Conditions.

PRO Subscription - monthly installments provides the option to suspend (freeze) the service up to two times for a period of one full calendar month (from the first to the last day of the month), within the term of the Subscription. The freeze cannot be applied for partial periods (e.g. from date to date). Subscription freeze shall be made upon written request of the Customer in accordance with Section II.

(New provision)

*Before the expiry of the term of the Contract for this subscription, the Customer may request its early termination by submitting a written termination request and activating a three-month notice period. The notice period shall commence on the date on which the Customer's next subscription month begins, according to their individual subscription cycle. Upon submitting the termination request, the Customer must pay in advance the amount corresponding to three monthly subscription fees, covering the notice period. During the notice period, the Customer shall retain full access to the services under their subscription plan.

In the event of early termination of the Contract at the Customer's initiative, without submitting a written termination request and without the advance payment of the three monthly fees, the Customer shall owe a penalty equal to three monthly subscription fees, payable at the time of termination of the Contract.

**The amendment to the General Terms and Conditions concerning the option to terminate the Contract without penalty with a three-month notice period applies only to Customers who have concluded a Contract for the specified subscription after 14 November 2025. Contracts concluded before this date shall be performed under the terms and conditions in force at the time of their conclusion.*

3. BASIC Subscription

BASIC Subscription: With this type of Subscription, the Customer shall have the opportunity to use a monthly subscription, where the Customer shall pay the fee for the BASIC Subscription in advance and shall have the right to use the services for a period of one month, which shall begin on the day of payment of the fee or on another agreed date and shall end at 00:00 on the relevant day of the month (*if this month does not have a relevant number, the period shall expire on its last day). The BASIC Subscription can be concluded at any of the Company's Facilities, by signing a Contract for the Provision of Sports Services, as well as online on the website <https://www.nextlevelclub.bg/tseni/> and through the mobile application Next Level Fitness App - under the terms of a Distance Contract.

According to the [Company's Price List](#), the Customer may choose whether the BASIC Subscription shall apply only to one Facility or to all Next Level Fitness OOD Facilities, as well as whether it shall be valid for group classes or not.

4. Pro Single Club – Annual Subscription

The Pro Single Club – Annual Subscription provides the Customer with the opportunity to enter into a Contract for the Provision of Sports Services /Distance Contract for a fixed period of 12 (twelve) full calendar months upon payment of equal monthly installments due by the end of the period, in accordance with the Company's price list. The twelve-month period always begins on the first day of the respective month. If the Customer's chosen effective date for the Contract for the Provision of Sports Services /Distance Agreement does not coincide with the first day of the calendar month (e.g., October 12.2025), a proportional part of the monthly fee will be due for the period from that date until the first day of the next calendar month. This partial period is not included in the twelve-month term of the Pro Single Club – Annual Subscription. The fee for each of the subsequent twelve months, starting from the beginning of the first full calendar month (i.e., from the 1st day of the month following the partial period month), is due in full.

The Subscription shall entitle the Customer to an unlimited number of visits per day to one Facility of Next Level Fitness OOD, designated by the Customer upon purchase of the Subscription, together with its adjoining SPA areas (if any). By way of exception, where the designated Facility is located in the city of Burgas or in the city of Plovdiv, the Subscription shall entitle the Customer to an unlimited number of visits per day to all Facilities of Next Level Fitness OOD located within the territory of the respective city, together with their adjoining SPA areas (if any).

This type of subscription does not entitle the Customer to attend group classes.

The Pro Single Club – Annual Subscription allows you to save a bank card and activate an automatic payment option. By memorizing the bank card and activating the automatic payment option, the Customer expresses his/her unequivocal consent that an amount equal to the respective monthly subscription will be automatically withdrawn from the memorized bank card to pay the next monthly fee when it becomes due, guaranteeing the continuity of the concluded Contract. At any time, the Customer may withdraw his/her consent by deactivating the automatic payment option via the website or the Next Level Fitness App. Upon deactivation of the automatic payment option, the Customer shall independently make the monthly payments within the terms set out in these Terms and Conditions.

The Pro Single Club – Annual Subscription provides the option to suspend (freeze) the service up to two times for a period of one full calendar month (from the first to the last day of the month), within the term of the Subscription. The freeze cannot be applied for partial periods (e.g., from date to date). Subscription freeze shall be made upon written request of the Customer in accordance with Section II.

(New provision)

*Before the expiry of the term of the Contract for this subscription, the Customer may request its early termination by submitting a written termination request and activating a three-month notice period. The notice period shall commence on the date on which the Customer's next subscription month begins, according to their individual subscription cycle. Upon submitting the termination request, the Customer must pay in advance the amount corresponding to three monthly subscription fees, covering the notice period. During the notice period, the Customer shall retain full access to the services under their subscription plan.

In the event of early termination of the Contract at the Customer's initiative, without submitting a written termination request and without the advance payment of the three monthly fees, the Customer shall owe a penalty equal to three monthly subscription fees, payable at the time of termination of the Contract.

**The amendment to the General Terms and Conditions concerning the option to terminate the Contract without penalty with a three-month notice period applies only to Customers who have concluded a Contract for the specified subscription after 14 November 2025. Contracts concluded before this date shall be performed under the terms and conditions in force at the time of their conclusion.*

5. Quarterly Subscription

The Quarterly Subscription shall provide the Customer with the opportunity to use a type of subscription where they shall pay a fee, according to the [Company's price list](#), in advance, and shall have the right to an unlimited number of visits per day, for a period of three months (e.g. from 23.02.2024 to 00:00 on 23.05.2024).

The Quarterly Subscription may be purchased either as a subscription valid for all Facilities of Next Level Fitness OOD or as a subscription valid only for the Facilities of Next Level Fitness OOD in the city of Burgas or the city of Plovdiv, in accordance with the Company's Price List.

Where the Customer has selected a subscription valid for the city of Burgas or the city of Plovdiv, the Subscription shall entitle the Customer to an unlimited number of visits per day to all Facilities of Next Level Fitness OOD located within the respective city. In all other cases, the Quarterly Subscription shall entitle the Customer to an unlimited number of visits per day to all Facilities of Next Level Fitness OOD.

The subscription period shall begin on the day of payment of the fee or on a date explicitly specified by the Customer and shall end at 00:00 on the relevant day of the third month (**if this month does not have a relevant number, the period shall expire on its last day*). Upon expiration of the three-month period, the subscription shall be terminated.

This type of subscription shall not give the right to attend group classes.

The Quarterly Subscription can be concluded through a Distance Contract online at: <https://www.nextlevelclub.bg/tseni/>, through the mobile application "Next Level Fitness App", as well as in physical locations of Next Level Fitness Ltd.

6. Back2School – Three-month Subscription

The Back2School – Three-monthSubscription allows the Customer to use a type subscription, whereby the Customer prepays the Back2School fee in advance, in accordance with the Company's price list, and is entitled to use the services at a Next Level Fitness OOD. Facility specified in advance upon purchase of the Subscription, during the hours between 09:00 and 16:00. The term of the Subscription shall be three calendar months and shall commence on the first day of the calendar month following the month in which the Subscription was activated, regardless of the date of its activation, and shall end at 00:00 on the last day of the third month.

Depending on the commencement date of the Subscription, the fee for the first month shall be payable as follows:

In the event that the Subscription does not commence on the first day of the calendar month (e.g. on 12.02.), a proportional part of the monthly fee shall be due for the first month, calculated based on the number of days remaining until the end of the respective month and the total number of days in that month. This period shall not be included in the three-month term of the Subscription and shall not be considered part of that term. The fee for each subsequent month shall be payable in full;

Where the Subscription commences on the first day of the calendar month, the fee shall be payable in full, in accordance with the Company's price list.

Together with the first payment, the Customer shall also pay a deposit in the amount of ten euros. The deposit may be used to offset the last monthly Subscription fee due, provided that the Subscription has not been terminated prematurely. Next Level Fitness OOD. shall have the right to retain the deposit under the terms of these Terms and Conditions.

The monthly Subscription instalment shall be paid in advance, no later than the 5th day of the month to which it relates, unless otherwise agreed in the Sports Services Agreement/Remote Agreement. In the event of failure to fulfil the payment obligation within the specified time limit, the respective general rules for suspension of access and termination of the Subscription applicable to the relevant type of Subscription shall apply, and the deposit paid shall be retained as a contractual penalty for failure to fulfil the Customer's obligations.

The Back2School Subscription may be concluded at any Facility of the Company through signing a Contract for the Provision of Sports Services, as well as online at: <https://www.nextlevelclub.bg/tseni/> and via the Next Level Fitness App, under the terms of a Distance Contract.

The Subscription entitles the Customer to visits between 09:00 a.m. and 04:00 p.m. at one Facility of Next Level Fitness OOD., designated by the Customer upon purchase of the subscription, together with its adjoining SPA areas (if any).

This type of subscription does not entitle the Customer to attend group classes.

The Subscription may be purchased only by individuals aged between 14 and 18 years.

7. Weekly Fitness Subscription

The **Weekly Fitness Subscription** shall provide the Customer with the opportunity to use a type of subscription where they shall pay a fee, according to the [Company's price list](#), in advance, and shall have the right to an unlimited number of visits per day to all Next Level Fitness OOD Facilities, for a period of 7 (seven) days. The subscription period shall begin on the day of payment of the fee or on a date explicitly specified by the Customer and shall end at 23:59 on the seventh day.

The Weekly Subscription does not grant the right to attend group classes.

The Subscription can be concluded through a Distance Contract online at: <https://www.nextlevelclub.bg/tseni/>, through the mobile application "Next Level Fitness App", as well as in physical locations of Next Level Fitness Ltd.

8. Weekly Subscription for Group Classes and Fitness

The Weekly Subscription for Group Classes and Fitness provides the Customer with the opportunity to use a type of Subscription whereby the Customer pays the fee in advance, in accordance with the Company's price list, and is entitled to an unlimited number of visits per day to all Next Level Fitness OOD. Facilities, as well as to one (1) visit per day to group classes at all Next Level Fitness OOD. Facilities where such classes are offered, for a period of 7 (seven) days. The term of the Subscription shall commence on the day the fee is paid or on a date expressly specified by the Customer and shall expire at 23:59 on the seventh day.

The Weekly Subscription for Group Classes and Fitness may be concluded under a Remote Agreement online via the following website: Next Level Fitness price page, through the "Next Level Fitness App", as well as at the physical Facilities of Next Level Fitness Ltd.

9. Free Pass – Free Visit

Free Pass – Free Visit constitutes a Sports Service provided by Next Level Fitness OOD. under the terms of these Terms and Conditions, which entitles the Customer to a single visit to a Next Level Fitness OOD. Facility selected by the Customer for the

use of a fitness service or attendance at a group class offered at the respective Facility, free of charge.

In order to use the Free Pass, the Customer shall create a customer profile and conclude a Sports Services Agreement. The right to use the Free Pass shall arise upon the creation of a customer profile, activation of the Free Pass and conclusion of a Sports Services Agreement in accordance with the applicable procedure.

The Free Pass may be activated at the physical Facilities of Next Level Fitness OOD., as well as online via the Company's website and/or through the Next Level Fitness App, where such functionality is available.

The Free Pass may be used at all Next Level Fitness OOD. Facilities. The Free Pass shall be activated for a specific Facility selected by the Customer and shall entitle the Customer to one visit only to that Facility. The Free Pass may not be used at a Facility other than the one selected upon its activation.

The Free Pass shall be valid for a period of 7 (seven) days from the date of its activation. Within this period, the Customer shall be entitled to use the single visit. Upon use of the visit or expiration of the 7 (seven)-day period, the Free Pass shall be considered exhausted and may not be used again.

The Free Pass provides access to a fitness service or a group class selected by the Customer at the respective Facility. Access to a specific group class shall be subject to the approved schedule of the respective Facility and availability, and additional conditions, including age restrictions, may apply to participation in a specific group class.

The Free Pass may only be used by individuals who have reached the age of 14 (fourteen) years.

The Free Pass shall be provided only to new Customers of Next Level Fitness OOD. or to Customers who have not used Sports Services at Next Level Fitness Ltd. Facilities during the preceding 6 (six) months, calculated from the date of activation of the Free Pass.

Each Customer shall be entitled to use a Free Pass once for one selected Facility within each 6 (six)-month period. Where a Free Pass has been used at a particular Facility, the Customer may not use another Free Pass for the same Facility before the expiration of 6 (six) months from the date of activation of the previous Free Pass.

The Free Pass is personal and may not be transferred or assigned to another person, nor may it be exchanged for its monetary equivalent.

The activation and use of the Free Pass shall not entitle the Customer to any additional visits or to the use of other Sports Services or Next Level Fitness OOD. Facilities beyond the single visit provided under the respective Free Pass.

The Free Pass may not be combined with another Free Pass for the same Facility within the same period, or with other promotional offers, unless expressly provided otherwise by Next Level Fitness OOD.

In order to use the Free Pass service, the Customer shall familiarize themselves with these Terms and Conditions and the Sports Services Agreement and confirm their acceptance thereof in accordance with the procedure applicable to the respective method of concluding the Agreement.

The Agreement for the service shall be concluded by signing the Sports Services Agreement.

10. Next Level Body Age

Next Level Body Age is an additional service offered by Next Level Fitness Ltd., which is not included in the membership plans and is provided against a one-time fee in accordance with the Company's price list.

The service includes a holistic assessment of the Customer's physical condition performed through the innovative "Technogym Checkup" device, equipped with integrated artificial intelligence, which conducts detailed measurements of body indicators. Based on the results, an individual report is generated.

The service is offered in the following packages:

- **Discover** – an unlimited number of measurements within a period of thirty (30) days using the "Technogym Checkup" device, through which the Customer receives a detailed report.

In order for a measurement to be performed, the Customer must use the Technogym application through which a user profile is created. The measured personal data and results are stored on servers administered by Technogym S.p.A., in accordance with the applicable Technogym S.p.A. Privacy Policy, with which the Customer becomes acquainted and agrees upon registration in the application.

Next Level Fitness Ltd. does not process such data and bears no responsibility for their protection or storage by Technogym.

The results and reports obtained are of an informational and indicative nature only and do not constitute a medical diagnosis, nor may they replace consultation with a healthcare professional.

11. KIDS 1 Club – a subscription for children's group activities

KIDS 1 Club represents a subscription for children's group activities, consisting of organized sports and physical activities conducted in a group format under the supervision of an instructor, and which may include non-contact activities, as well as contact and/or combat sports.

The monthly KIDS 1 Club subscription grants the Client, for whose benefit the subscription has been concluded, the right to attend six (6) children's group activities within a one-month period (e.g. from 23 February 2024 to 23 March 2024), calculated from the subscription start date until the corresponding date of the following month.

The subscription is valid only for the Next Level facility selected in advance at the time of purchase. The Client shall not be entitled to transfer or carry forward any unused visits to the following month.

This subscription provides access to all children's group activities offered at the respective Next Level Fitness facility at the relevant time, regardless of their type, subject to availability and in accordance with the approved schedule.

Access to children's group activities may be obtained either through the purchase of this subscription or through a valid Multisport Kids card/program, under the terms and conditions determined by the respective service provider.

Within the scope of the children's group activities, the following may be included, without the list being exhaustive:

- non-contact and general physical activities (e.g. dance, gymnastics, yoga, functional training, etc.);
- contact activities and/or combat sports (e.g. boxing, taekwondo, jiu-jitsu, wrestling, kickboxing, and other similar disciplines).

The specific type, content, and schedule of the activities shall be determined by Next Level Fitness for each facility and shall be published on the Next Level Fitness website, in the Next Level Fitness App, and/or on-site at the respective facility.

KIDS 1 Club is intended for children aged from six (6) to thirteen (13) years inclusive.

Depending on the specific type of activity, its intensity, and characteristics, additional age groups or restrictions may apply at certain facilities, which shall be explicitly indicated in the activity schedule, on the website, in the mobile application, and/or on-site at the facility.

The Client is responsible for ensuring that the child's age and physical condition meet the requirements for participation in the specific activity.

Attendance at activities shall take place in accordance with the approved schedule and, where applicable, following prior notification to Next Level Fitness of the intention to attend. Next Level Fitness reserves the right to refuse participation in a specific activity in cases of non-compliance with age requirements, lack of available capacity, or objective reasons related to the safety of children.

The Client acknowledges and accepts that certain children's group activities, including contact and combat sports, by their nature may involve health risks to participants, arising from the nature of the activity, the physical exertion involved, and interaction between participants.

Additional information regarding the nature of specific activities, potential risks, and participation requirements may be obtained from the Next Level Fitness website, the Next Level Fitness App, and/or at the reception desk of the respective facility prior to purchasing the subscription.

By accepting these General Terms and Conditions, the Client declares that they have familiarized themselves with this information and accept the associated risks.

Next Level Fitness reserves the right to:

- modify the types of children's group activities offered at a given facility;
- introduce or discontinue specific activities;
- amend the schedule and age group allocation,

without this constituting an amendment to these General Terms and Conditions or grounds for claims by the Client, provided that the subscription continues to grant access to children's group activities at the respective facility.

The subscription may be concluded at any Next Level Fitness facility where it is offered, as well as online via the website

<https://www.nextlevelclub.bg/tseni/> or through the Next Level Fitness App, under the terms applicable to distance contracts.

12. Group Class – Children's Boxing

The Group Class – Children's Boxing is a boxing class designed for children aged between 8 (eight) and 17 (seventeen) years. Boxing classes are held only in specific Next Level Fitness Clubs, according to a pre-approved schedule and divided into age groups, as follows:

- Group I – children aged 8 (eight) to 13 (thirteen) years, inclusive;
- Group II – children aged 14 (fourteen) to 17 (seventeen) years, inclusive.

The Children's Boxing Class entitles the Client, on whose behalf the subscription has been concluded, to 8 (eight) boxing sessions within one month (e.g. from 23.02.2024 to 23.03.2024), according to the approved schedule, upon prior payment of the applicable fee. The subscription is valid only for the specific Next Level Fitness Club selected at the time of purchase.

The Client may not transfer unused sessions to the following month.

Next Level Fitness must be notified in advance of the day on which the child will attend and the age group to which the child belongs. The subscription term starts on the date of payment or on a date expressly indicated by the Client and expires at 00:00 hours on the corresponding date of the following month (if the following month does not have the same date, the term expires on its last day). Upon expiry of the one-month period, the subscription automatically terminates.

This type of subscription does not grant access to other group classes.

A subscription for Group Class – Children's Boxing may be concluded at any Next Level Fitness Club where it is offered, as well as online at <https://www.nextlevelclub.bg/tseni/> and through the mobile application "Next Level Fitness App", under the terms of a Distance Contract.

13. Group Class – Pilates Reformer

The Group Class – Pilates Reformer is a Pilates-based group class conducted with the use of a specialized piece of equipment known as the Reformer. The classes are held only in specific Next Level Fitness Clubs, according to a pre-approved schedule.

The Group Class – Pilates Reformer entitles the Client, on whose behalf the subscription has been concluded, to 1 (one) session within one month (e.g. from 23.02.2024 to 23.03.2024), or 4 (four), 8 (eight) or 14 (fourteen) sessions within two months, according to the approved schedule, upon prior payment of the applicable fee. The number of sessions included in the subscription depends on the selected package: Pilates Reformer – 1 visit, which includes one session under the above conditions; Pilates Reformer – 4 visits, which includes four sessions under the above conditions; Pilates Reformer – 8 visits, which includes eight sessions under the above conditions; Pilates Reformer – 14 visits, which includes fourteen sessions under the above conditions.

The subscription is valid only for the specific Next Level Fitness Club selected at the time of purchase. The Client may not transfer unused sessions to the following month. Next Level Fitness must be notified in advance of the day on which the Client

will attend. The subscription term starts on the date of payment or on a date expressly indicated by the Client and expires at 00:00 hours on the corresponding date of the respective month (if such month does not contain the corresponding date, the term expires on its last day) following the month in which the subscription commenced. Upon expiry of the subscription term, the subscription automatically terminates. This type of subscription does not grant access to other group classes.

A subscription for Group Class – Pilates Reformer may be concluded at any Next Level Fitness Club where it is offered, as well as online at <https://www.nextlevelclub.bg/tseni/> and through the mobile application “Next Level Fitness App”, under the terms of a Distance Contract.

14. Individual Session – Pilates Reformer

The Individual Session – Pilates Reformer is a Pilates-based one-on-one session conducted with the use of a specialized piece of equipment known as the Reformer. The sessions are held only in specific Next Level Fitness Clubs, according to a pre-approved schedule.

The Individual Session – Pilates Reformer entitles the Client, on whose behalf the subscription has been concluded, to 1 (one), 4 (four) or 8 (eight) session visits within one month (e.g., from 23.02.2024 to 23.03.2024), according to the approved schedule, upon prior payment of the applicable fee. The number of visits included in the subscription depends on the selected package: Pilates Reformer – 1 visit, which includes one session under the above conditions; Pilates Reformer – 4 visits, which includes four sessions under the above conditions; Pilates Reformer – 8 visits, which includes eight sessions under the above conditions. The subscription is valid only for the specific Next Level Fitness Club selected at the time of purchase. The Client may not transfer unused sessions to the following month. Next Level Fitness must be notified in advance of the day on which the session will be conducted. The subscription term starts on the date of payment or on a date expressly indicated by the Client and expires at 00:00 hours on the corresponding date of the following month (*if the following month does not have the same date, the term expires on its last day). Upon expiry of the one-month period, the subscription automatically terminates.

This type of subscription does not grant access to other activities. A subscription for Individual Session – Pilates Reformer may be concluded at any Next Level Fitness Club where it is offered, as well as online at <https://www.nextlevelclub.bg/tseni/> and through the mobile application “Next Level Fitness App”, under the terms of a Distance Contract.

II. TERMS OF CONCLUSION. SUBSCRIPTION TERMINATION, SUBSCRIPTION SUSPENSION

1. The subscription and the rights related to it shall apply only to the Customer who has concluded a Contract for the Provision of Sports Services or a Distance Contract and may not be transferred to third parties without prior written notification to Next Level Fitness OOD. The Company shall provide for the possibility of transferring the subscription (respectively the rights and obligations thereunder) to a third party by filling out an application for the transfer of a subscription. The application for the transfer of a subscription can be submitted via a form (available at the Company's Facilities) at the reception in any of the Company's Facilities, as well as in free text via registered mail to the address of Next Level Fitness OOD or to the email address: info@nextlevelfitness.bg. **IMPORTANT!** It shall be mandatory for the person to whom the subscription is transferred to have registered on the company's website (<https://www.nextlevelclub.bg/>). The rules for transferring a Subscription under this item shall not apply to customers with a BASIC Subscription, whose holders shall not have the right to transfer it to third parties.
2. Persons between the ages of 14 and 17 included may conclude Contracts for the Provision of Sports Services and Distance Contracts for the following Subscription plans: BASIC Subscription, EASY Subscription, Back2School – Three-month Subscription, Group Class – Children's Boxing, Group Class – Pilates Reformer, Individual Session – Pilates Reformer.
3. The Parties may terminate the Contract for the Provision of Sports Services or the Distance Contract by mutual consent.
4. The Contract for the Provision of Sports Services or the Distance Contract for EASY Subscription may be terminated by the Customer with a notification sent no later than the 20th day of the respective already paid full monthly period. The effect of the notification under the preceding sentence shall be that the EASY Subscription shall be terminated upon the expiry of the monthly period following the monthly period in which the notification was sent. Customers have the right to submit a notice of termination of the Contract for the Provision of Sports Services or the Distance Contract after the expiration of the first full monthly period (a full calendar month) of the EASY Subscription.

EXAMPLE: A Customer signs up for a 6-month EASY Subscription on 5 January of the respective year. On the same day, they activate their account and pay the initial 1-month period from 5 January to 00:00 on 5 February, as well as the required deposit in the amount of one monthly fee. After confirmation that the subscription is active, the Customer may visit the Company's Facilities. In case after the expiry of the initial 1-month period (at 00:00 on 5 February) the Customer decides that they wish to terminate the EASY Subscription, they should send a notice of termination to Next Level Fitness OOD by 25 February. As a result of the notice of termination, the Customer's EASY Subscription will be considered terminated with the expiry of the monthly period following the monthly period in which the notice was sent, namely on 5 April. In other words, the notice was sent in the monthly period 5 February - 5 March and the EASY Subscription is terminated with the expiry of the next monthly period - 5 March - 5 April. In the example given, the Customer pays fees for the monthly periods 5 January - 5 February and 5 February - 5 March, and for the monthly period 5 March - 5 April, the fee is repaid from the initially paid deposit.

5. Early termination of the Pro Single Club – Annual Subscription and the PRO Subscription – Monthly Installments shall be carried out in accordance with the procedure and conditions described in the respective subscription description in these General Terms and Conditions. The Customer shall owe a penalty only in cases of failure to comply with the requirements set out herein regarding the submission of a termination request and the advance payment. These rules apply to contracts concluded after 14 November 2025; contracts concluded before this date shall remain governed by the terms and conditions in force at the time of their conclusion.
6. Upon submission of a document certifying the inability to exercise sports activities for medical reasons lasting more than 1 month by the Customer, the Contract shall be terminated by Next Level Fitness OOD as of the 1st day of the reporting period to which the submitted document refers. In these cases, Next Level Fitness OOD shall not owe a refund of the amounts prepaid under the respective Subscription.

7. The BASIC Subscription shall expire at 00:00 on the relevant day of the month (*if this month does not have a relevant number, the period shall expire on its last day). The Customer may not terminate this type of Subscription early.
8. The Weekly Subscription expires at 23:59 on the seventh day of the Subscription period. The Customer is not entitled to premature termination of this Subscription.
9. A Customer, an individual, shall be a consumer within the meaning of the Consumer Protection Act and shall be entitled, without owing compensation or penalty and without giving a reason, to withdraw from a Distance Contract concluded electronically within 14 (fourteen) days from the conclusion of the contract.
10. The withdrawal shall be made by sending an unambiguous notification to Next Level Fitness OOD by email (info@nextlevelfitness.bg) or to the mailing address of the Company, as well as to the reception of each of the Company's Facilities, in writing, of the receipt of which Next Level Fitness OOD shall inform the Customer.
11. When a Customer - an individual, a consumer within the meaning of the Consumer Protection Act, who has concluded a Contract for the Provision of Sports Services (Distance Contract) electronically, exercises their right of withdrawal after having made a request to Next Level Fitness OOD for the provision of the Sports Services before the expiration of the period for withdrawal from the Contract for Sports Services, they shall owe to Next Level Fitness OOD the proportional amount of what was actually provided to them up to the moment of withdrawal.
12. Next Level Fitness OOD shall reserves the right to terminate the Contract for the Provision of Sports Services or the Distance Contract with immediate effect in the event of a material breach by the Customer of the Sports Services Agreement, these Terms and Conditions, or the Rules for the Use of Sports Services and the Customer Area of Next Level Fitness OOD., as well as in the event of the Customer's failure to comply with instructions issued by the management of Next Level Fitness Ltd. or by personnel responsible for the operation and safety of the Company's Facilities, relating to the safety, order and normal operation of the Facility, without it being necessary for such breach to be repeated. For the purposes of this clause, a material breach shall also include a breach by the Customer of item 14 of the Club Rules (the obligation to maintain order, cleanliness and tranquillity in the fitness facility and to behave politely and respectfully towards others), a breach by the Customer of item 17.4 of the Club Rules (creating situations in which the safety of other persons exercising is endangered), or the occurrence of the circumstances set out in item 15 of the Club Rules (inappropriate behaviour by a Customer giving the Club staff grounds to prohibit the Customer from entering or to remove the Customer from the Club, including prohibiting the Customer from returning to the Club), as well as other antisocial conduct by the Customer occurring at the Facility, beyond the cases specified above. A single breach may also be considered a material breach where, having regard to its nature, severity, consequences or the risk created to the health, safety or dignity of other Customers, employees, instructors or third parties, it justifies such qualification.
If Next Level Fitness OOD terminates the Contract for the Provision of Sports Services or the Distance Contract in accordance with this clause, the Company shall have the right to retain all fees paid to that point as a contractual penalty for the breach of the Contract for the Provision of Sports Services or the Distance Contract, even if they relate to a period after their termination. In addition, the Customer shall be obliged to pay the Company a contractual penalty in an amount equal to the Subscription fee for three months (in the standard amount for the respective type of subscription, regardless of discounts). This shall not prejudice the right of Next Level Fitness OOD to claim compensation for the damages suffered in full. The Subscription may be renewed and a new Contract for the Provision of Sports Services or the Distance Contract concluded, respectively, only if the Customer has paid all (including previous) outstanding amounts and fulfilled all payment obligations, i.e. the Customer shall have no obligations to the Company.
13. Upon termination of the Sports Services Agreement or the Remote Agreement due to a material breach by the Customer, Next Level Fitness shall have the right, for a period of up to 6 (six) months from the date of termination of the Agreement, to refuse to conclude a new Sports Services Agreement with the Customer, including to refuse the sale or activation of a new Subscription or other Sports Service, regardless of the Next Level Fitness Facility at which the Customer wishes to use the service. Upon expiry of the said 6 (six)-month period, the Customer may again conclude a Sports Services Agreement and purchase Sports Services under the terms and conditions applicable at the relevant time, unless, in the meantime, a new ground for refusal has arisen under these Terms and Conditions or the applicable legislation. The measure referred to in the preceding sentences shall apply in the event of breaches which, having regard to their nature, severity, consequences or the risk created to the health, safety, dignity or tranquillity of other Customers, employees, instructors or third parties, objectively justify the need for a temporary restriction on the possibility of concluding a new Agreement.
**The amendments to items 12 and 13 shall apply only to Customers who have concluded an agreement/service agreement after their entry into force.*
14. A Customer shall have the right to file a complaint about a service when it does not comply with a Contract for the Provision of Sports Services and/or a Distance Contract:
 - 14.1. When filing a complaint, the Customer may claim to bring the service into compliance with the concluded contract, to reduce the price or to terminate the contract and refund the amount paid.
 - 14.2. When filing a complaint, the Customer shall indicate the subject of the complaint, their preferred method of satisfying the complaint, respectively the amount of the claimed amount, and a contact address.
 - 14.3. When filing a complaint, the Customer shall also necessarily attach the documents on which the claim is based:
 1. receipt or invoice;
 2. protocols, acts or other documents establishing the non-compliance of the service with the agreement;
 3. other documents establishing the claim by reason and amount.
 - 14.4. Next Level Fitness OOD shall prepare a statement and response to the submitted complaint within 30 days of its submission.
 - 14.5. When Next Level Fitness OOD satisfies the complaint, it shall issue an act to that effect, which shall be drawn up in two copies, and one copy must be provided to the consumer.
15. Upon the written request of a Customer with an EASY Subscription or a PRO Subscription - monthly installments, without stating a reason, Next Level Fitness Ltd. may suspend ("freeze") the Subscription for a period of 1 month, in the case of EASY Subscription, such suspension ("freeze") may only be used once every 12 months of the duration of the Sports Service Contract or Distance Contract, and in the case of PRO Subscription - monthly instalments, up to twice within the

- duration of the Sports Service Contract or Distance Contract. In the event that a Subscription is suspended ("frozen"), its duration will be extended by the period of the freeze (e.g. if two "freezes" are used, the duration of the Subscription will be extended by two months.).
16. The request for suspension ("freezing") must be sent to Next Level Fitness OOD by email (info@nextlevelfitness.bg), by registered mail to the mailing address of the Company, or deposited at the reception of a selected Facility of the Company in explicit written form, and must be sent/deposited no later than the 20th day of the monthly period of the subscription preceding the monthly period for which the suspension ("freezing") is requested.
 17. During the period of suspension ("freezing") of the Subscription, the Customer shall not be entitled to use the services, as the subscription fee shall not be paid.
 18. When concluding a subscription through the mobile application Next Level Fitness App, to finalize the process and conclude the Contract for the Provision of Sports Services / Distance Contract, the consumer shall sign the Contract by clicking the "Confirm subscription" button. This action shall be considered signing the Contract for the Provision of Sports Services / Distance Contract.
 19. Signing a Contract for the Provision of Sports Services / Distance Contract through the mobile application Next Level Fitness App shall be optional, as customers shall have the right to conclude a Contract for the Provision of Sports Services / Distance Contract also at the website: <https://www.nextlevelclub.bg/tseni/>, as well as in the physical locations of Next Level Fitness OOD, according to the specifics agreed in these General Terms and Conditions.
 20. Each purchased Subscription, regardless of the manner in which it was concluded - on site or online, will be verified by a Next Level Fitness OOD employee at the first visit of the Customer, in order to establish the identity of the Customer. For this purpose, Next Level Fitness OOD shall have the right to request that the Customer present an identity document (ID card) in order to verify the personal data provided by the Customer, in cases where the registration or, respectively, the Subscription has been made online or through the Next Level Fitness App, as well as in cases where the Agreement is concluded on-site, in order to verify the data provided at the reception desk. This shall also apply when concluding an Agreement for the Free Pass – Free Visit service.
 21. The Customer and Next Level Fitness OOD shall agree, pursuant to Art. 13, para. 4 of the Electronic Documents and Electronic Certification Services Act, that the legal force of the ordinary electronic signature shall be equivalent to that of the Customer's handwritten signature.

III. SUBSCRIPTION FEE, PAYMENT TERMS

1. For the provided Sports Services, the Customer shall be obliged to pay a fee to Next Level Fitness OOD in the amount specified in the [Company's price list](#) for the relevant invoicing period (referred to as "**Subscription Fee**").
2. The invoicing periods for the PRO Subscription shall be for the first 3 months of the subscription and for the remaining 9 months, respectively. The fee for the first 3 months shall be paid upon conclusion of the Contract for the Provision of Sports Services or the Distance Contract. The fee for the remaining 9 months shall be paid until the expiration of the initially paid 3 months.
3. The billing period for the PRO Subscription – Monthly Installments is 1 month once the twelve-month period begins. The Customer may also owe a proportional fee if the effective date of the Contract for the Provision of Sports Services /Distance Agreement does not coincide with the first day of a calendar month. The first payment for the PRO Subscription – Monthly Installments is made upon signing the Contract for the Provision of Sports Services or the Distance Agreement, respectively. The fee for each subsequent monthly period after the first is due no later than the 5th day of the relevant month and in accordance with these General Terms and Conditions, unless otherwise agreed in the Contract for the Provision of Sports Services or the Distance Agreement.
4. The invoicing period for the EASY Subscription shall be 1 month when the respective period begins with a full month. The fee for the first period (partial or full calendar month) of the EASY Subscription is paid upon the conclusion of the Contract for the Provision of Sports Services or the respective Distance Contract, simultaneously with the deposit as per these General Terms and Conditions. The fee for each subsequent monthly period after the first period is due no later than the 5th day of the respective month and in accordance with these General Terms and Conditions, unless otherwise agreed in the Contract for the Provision of Sports Services or the respective Distance Contract.
5. The invoicing period for the BASIC Subscription shall be one month, payable on the first day of this subscription or before its start.
6. The invoicing period for the Quarterly Subscription shall be three months. The Subscription Fee shall be paid in advance upon conclusion of a Distance Contract. The billing period for the Pro Single Club – Annual Subscription is one month, starting from the commencement of the twelve-month period. The first partial monthly fee, due upon conclusion of the Contract for the Provision of Sports Services or the corresponding Distance Contract, shall not be charged and is free of charge. The fee for the first and each subsequent monthly period is due no later than the 5th day of the respective month, in accordance with these Terms and Conditions. If the Customer is in default of payment of the subscription fee (or any part thereof) or with any other payment that the Customer must pay to the Company, Next Level Fitness OOD shall be entitled to deny the Customer access to the Company's Facilities until the Customer has fully paid the remaining part of their obligation, and to unilaterally suspend the provision of the Services. This condition shall not cancel the Customer's obligation to pay the relevant subscription fees for the period in which the provision of the Services is suspended in accordance with this provision. Next Level Fitness OOD shall reserve the right to claim, including by judicial means, all amounts due and payable under the concluded Contracts, as well as to use the services of third parties in the voluntary or judicial collection of these receivables, including to transfer (assign) these receivables to third parties under the terms and conditions of the applicable legislation.
7. The fact that the Customer does not use the Sports Services of the specific Facility shall not exempt them from the obligation to pay the relevant Subscription Fee. With the exception of the cases specified in these General Terms and Conditions, Next Level Fitness OOD shall not compensate or refund the Subscription Fees due for the term of the Contract in this case.
8. Next Level Fitness OOD shall reserve the right to change its price list, including amounts, terms and methods of payment.

The change shall not affect Subscriptions already purchased, as the old terms will continue to apply until the expiration date of the relevant Subscription. The changes shall apply only to Contracts signed after the price list change (also in the event of Contract extension). In the event of a change in taxes or fees imposed by law or other regulatory act, Next Level Fitness OOD shall have the right to apply the legally determined tax rate automatically to the final prices specified in the current price list and in the current Service Contracts concluded with the Customers.

9. Next Level Fitness OOD shall also reserve the right to index the prices of the services at the beginning of each calendar year, using the average annual consumer price index announced by the National Statistical Institute for the previous calendar year. This increase shall be applicable to all subscription fees from the day on which the increase is published by Next Level Fitness OOD on the official website or in another appropriate manner in the Company's Facilities.
10. Subscription fees can be paid in cash at the Company's Facility or by bank transfer to the bank account of Next Level Fitness OOD specified in the Contract for the Provision of Sports Services or the Distance Contract, as well as on the Company's website, by debit card, credit card or in another manner expressly specified by Next Level Fitness OOD.

IV. OTHER TERMS AND CONDITIONS

1. These General Terms and Conditions shall be published on the website of Next Level Fitness OOD <https://www.nextlevelclub.bg/dokument/> .
2. For all issues not regulated in these General Terms and Conditions, the applicable legal provisions shall apply.
3. All communications between Next Level Fitness OOD and a Customer in connection with a concluded contract for Sports Services or a Distance Contract shall be made in writing to the specified mailing addresses. The written form shall be deemed to have been complied with if communication is duly exchanged using email, again to the email addresses specified in the contracts and these General Terms and Conditions.
